Explain the reason: The corporate income tax after-tax profit for the fourth quarter of 2025 differed from the same period in 2024 mainly due to the fact that, in Q4 2025, the Company recorded income from securities trading (approximately VND 37.9 billion), which resulted in a significant increase in after-tax profit, turning a loss in the same period of the previous year into a profit in the current year.
